

HOW TO RESEARCH A WISCONSIN CHARITABLE ORGANIZATION:

Step 1: Enter Search Criteria

From the WI DFI Website Home Page (dfi.wi.org), select 'Business Services' then choose 'Charitable Organization Online Search'. Click on 'Registration Search' then 'Organization Credential Search'

Step 2: Enter Search Criteria

Select "Charitable Organizations (800)" from the Profession dropdown and enter any part of the firm name (partial names are accepted).

Step 3: Select from Result List

Select your desired organization from the result list by clicking the Hyperlink Name. If your desired organization is not in the list, try searching again using a different part of the name. You may need to try searching with abbreviations.

Step 4: View Status

Verify the Status of the Charity in the Summary. If you plan to make a donation to the charity, make sure that its license is Current.
