



# UCC Data Sales

## Purchase

**Step 1: Navigate to the UCC Data and Image Sales options.**

Select **Filings > UCC** from the menu after logging into the online account.

In the Data Sales section, there are five options to choose from when purchasing data and images for lien filings.

- **Full UCC Database:** This file contains the data for all active liens and for liens that have lapsed within the last one year. This file is generated on the 4<sup>th</sup> of each month for data including the end of the prior month. When you purchase this file, you will receive the most recent version. No images are included. The cost is \$500.00.
- **Weekly UCC Database Updates:** After purchasing the full database above, keep it up to date with weekly updates. These are produced every Wednesday for the previous Sunday through Saturday week. No images are included. The 6 most current weeks are available to purchase at \$250.00 per week.
- **Weekly UCC Images:** These files contain all of the images for filings in each week. They are produced every Wednesday for the previous Sunday through Saturday week. No data is included. The 6 most current weeks are available to purchase at \$250.00 per week.

- **Custom Weekly UCC Database:** These are the same files that are produced for the Weekly UCC Database Updates, but this option allows you to go back 52 weeks and purchase multiple weeks. The weeks do not have to be sequential. No images are included. These files are available to purchase at \$250.00 per week.
- **Custom Weekly UCC Images:** These are the same files that are produced for the Weekly UCC Images, but this option allows you to go back 52 weeks and purchase multiple weeks. The weeks do not have to be sequential. No data is included. These files are available to purchase at \$250.00 per week.

Click on the item that you want to purchase. For this example, we will choose the Weekly UCC Database Updates.

**Step 2: Choose records.**

The system will display the UCC Weekly Database Sales screen.

## Retrieval

### Step 1: Navigate to the Dashboard

When logged into the system, retrieve your purchased data or image file(s) from your Dashboard.

You can access the files from the **Data Sales** tab on the Dashboard main page. This will bring up a list of all purchased files that are currently available.

### Step 2: Download

Click on the Download File link to download the selected .zip file to your computer. Save and extract the files to the desired location on your computer or network.

## **File Format- Database**

The data is delivered in the form of 4 pipe delimited value (txt) files.

- Debtors.txt
- FilingDetail.txt
- LienDetail.txt
- SecuredParty.txt

**Note that these files are very large, each containing millions of rows of data. This exceeds the row count that can be opened using Microsoft Excel and many other common tools. These files are intended to be loaded into a database or other system that is designed to handle large volumes of data.**

Each of these files contains filing data that can be related to a filing by the IFS number and Filing Number provided. The first row of each file contains the column headers.
