# LOAN COMPANY LICENSE APPLICATION INSTRUCTIONS

**Purpose:** A completed Loan Company License Application should be submitted to the Department of Financial Institutions – Division of Banking ("division") for consideration of licensure. Upon the filing of such application the division shall investigate the relevant facts, and if the division finds that the character, general fitness, and financial responsibility of the applicant, including key officers, directors, members, partners, or owners, warrant the belief that the business will be operated in compliance with Section 138.09, Wis. Stats., the division shall issue a license.

**Notice:** This form is required under Section 138.09, Wisconsin Statutes. Refusal to provide this information may result in the denial of a license. Failure to complete this application completely and accurately may result in denial or revocation of license, and any other penalties as provided by law. Personally identifiable information on this form may be matched against tax information, outstanding child and family support data and law enforcement agencies. This document can be made available in alternate formats upon request to qualifying individuals with disabilities.

A Loan Company License Application can be submitted to the division by mail or online through the Nationwide Multistate Licensing System & Registry (NMLS).

- If submitting the application by mail, use this form.

# A) Surety Bond

Each applicant shall provide a surety bond in the amount of \$5,000 per proposed licensed location, or \$50,000, whichever is less. The bond form is found on the Department of Financial Institutions' website, dfi.wi.gov, by selecting Financial Services and then Licensed Financial Services Applications and Forms. The bond must:

- <u>not</u> reference a street address.
- identify the <u>exact</u> name of the applicant.
- identify all trade names or DBA (doing business as) names that the applicant uses. If using more than one DBA, please call our office for further instructions.
- identify only the fictitious name of the applicant if the Corporations Section of the Wisconsin Department of Financial Institutions required the applicant to obtain a fictitious name.
- be the <u>original</u> surety bond. The <u>original</u> power-of-attorney form must also be submitted with the bond.
- be signed by an officer/owner/member/partner whose signature is witnessed or sealed.

Should you choose not to use the available bond form, the submitted bond will be reviewed by legal staff to determine if it meets with the division's approval. The applicant shall be listed as the obligor, and the bond shall run to the state of Wisconsin for the use of the state and of any person or persons who may have a cause of action against the obligor of the bond under the provisions of s. 138.09, Stats. Such bonds shall be conditioned that the obligor will conform to and abide by each and every provision of s. 138.09, Stats., and will pay to the state or to any person or persons any and all moneys that may become due or owing to the state or to such person or persons from the obligor under and by virtue of the provisions of ch. 138, Stats. The provisions of an acceptable bond will:

- cover all locations licensed under Section 138.09, Wis. Stats.
- be in the required amount
- not allow for a decrease in the bond amount without 30 days written notice via certified mail to the division
- have acceptable issue and effective dates
- list examination costs as a preferred claim
- be continuous until cancelled
- require that within 10 days of the receipt of any claim, the surety inform the division in writing of the receipt of the claim
- require a minimum of 60 days written notice via certified mail of the cancellation of the bond
- indicate that written notice of claims may be filed for a minimum of 12 months after date of cancellation
- require that surety pays or denies claim within a maximum of six months after receipt of claim
- identify the name and address of claims agent

## B) Financial Statements

An internally prepared balance sheet and income statement must be submitted for the applicant. Audited financial statements should also be submitted if the applicant is audited by a certified public accountant on an annual basis.

The financial statements that are submitted to the division must:

- be prepared according to Generally Accepted Accounting Principles using accrual basis accounting.
- be for the legal entity that is applying for the license (the parent's financial statements are not acceptable).
- be consolidated if the applicant has subsidiaries.
- show a minimum tangible net worth of \$50,000 and positive net working capital (current assets current liabilities).
- be dated no more than 90 days prior to the date this application is received by the division.

The following information must be attached to the financial statements:

• an itemization of the "Other Assets" category (if the balance sheet includes an "Other Assets" category)

- documentation that verifies the cash balance listed on the balance sheet (this only needs to be submitted if cash accounts for more than 20% of the total assets)
- an explanation of how the applicant will maintain a tangible net worth of at least \$50,000 at all times (this only needs to be submitted if the applicant's equity is at or near the minimum amount required by the division)

When evaluating a financial statement, the division typically discounts intangible assets; receivables from officers, stockholders, and other related parties; employee advances, receivables over 120 days past due, and any other assets of questionable value.

If the applicant is a sole proprietorship, provide a personal financial statement dated no more than 90 days prior to the date this application is received by the division.

If the applicant is a partnership, <u>each</u> partner must submit a personal financial statement dated no more than 90 days prior to the date this application is received by the division.

### C) <u>Fees</u>

\$800 must be submitted for <u>each</u> location where loan company business will be conducted. The \$800 fee consists of a \$500 license fee and a \$300 nonrefundable investigation fee.

### D) <u>Certificate of Good Standing (if applicable)</u>

If the applicant is organized or incorporated in a state other than Wisconsin, provide the division with a certificate of status/certificate of good standing from the state where the applicant is organized or incorporated. The status/certificate should be dated within the previous 90 days and reflect the correct name and the date of organization or incorporation.

### E) Criminal History Report

A criminal history report must be submitted for each individual who owns 10% or more of the applicant and for each key officer, key member, or partner of the applicant. Key officers include, but are not limited to, the chief executive officer, chief operating officer, chief financial officer, president, executive or senior vice president (or the highest-level vice president if there is no executive or senior vice president), secretary, and treasurer. The criminal history report must be dated within the previous 90 days and <u>must</u> be obtained from the state police/Department of Justice located in the owner's/officer's/member's/partner's state of residence. Reports obtained from third-party background check providers will not be accepted.

## F) Officer/Director/Owner Resume(s)

Submit a resume for each individual who owns 10% or more of the applicant and for each key officer, director, key member, or partner of the applicant. The resume should include a summary of educational and employment experiences, the applicable dates of experience, positions held, name of company, and a description of duties. Key officers include, but are not limited to, the chief executive officer, chief operating officer, chief financial officer, president, executive or senior vice president, secretary, and treasurer.

### G) Business Plan

Submit a business plan outlining the following information: products and services, management team, marketing strategies, target markets, fee schedule, and operating structure the applicant intends to employ. If the applicant will purchase or sell/assign any loans that are subject to s. 138.09, Wis. Stats., identify who the loans will be purchased from and/or sold/assigned to (if known). Also describe at what point in the loan process the loans will be purchased or sold/assigned.

### H) Organizational Chart

Submit a chart showing the direct owners, indirect owners and subsidiaries and affiliates of the applicant.

I) Loan Documents

Submit copies of all documents Wisconsin customers will be asked to sign when obtaining a loan. Examples include, but are not limited to, applications, loan agreements, security agreements, payment authorization forms, and E-Sign Consent Statements. Please indicate if Wisconsin loan documents have not yet been developed.

### AFFIDAVIT (Page 15)

A duly authorized representative for the applicant should complete and sign the affidavit. A witness must certify the signature of the person signing the affidavit.

### STATE REGULATIONS YOU SHOULD REVIEW

Loan company licensees must comply with s. 138.09, Wis. Stats.; however, there are also many other state statutes and rules that include provisions that may apply to loan companies. Some of these regulations include:

- *Rule DFI-Bkg* 75.03(3) identifies limitations for s. 138.09 loans that are in the amount of \$1,500 or less.
- Section 138.14, Wis. Stats. if the applicant will loan an individual money and either hold the individual's check(s) for a period of time before presenting it or accept the individual's authorization to initiate one or more electronic fund transfers, then the applicant may be offering payday loans. Refer to this statute to determine if the applicant needs a payday lender license.
- *Rule DFI-Bkg* 75.02 explains what types of transactions are excluded from s. 138.14.
- *Chapter DFI-Bkg* 77 rules pertaining to a loan company who operates as a pawnbroker.
- *Chapters 421 427, Wis. Stats. –* also known as the Wisconsin Consumer Act.
- Chapter DFI-WCA 1 rules pertaining to the Wisconsin Consumer Act.
- Section 138.16, Wis. Stats. permits a licensed lender to make a loan secured by a motor vehicle if the licensed lender has obtained a Title Loan Certificate of Authorization from the division.
- Chapter 766, Wis. Stats. Wisconsin's marital property law. It includes information about the marital property notice that must be included in written applications for credit and the notice that lenders must send to non-applicant spouses.
- Chapter 224, subchapter III, Wis. Stats. pertains to mortgage banker licensing.
- Section 138.052, Wis. Stats. pertains to loans with 1<sup>st</sup> lien real estate mortgages or equivalent security interests.
- Section 138.056, Wis. Stats. pertains to variable rate mortgage loans.
- *Chapter 428, Wis. Stats.* pertains to 1<sup>st</sup> lien real estate mortgage loans in the amount of \$25,000 or less.

## WISCONSIN CONSUMER ACT INFORMATION

Pursuant to Section 426.201, Wis. Stats., a business that makes consumer credit transactions is required to register with the Bureau of Consumer Affairs ("BCA") of the Department of Financial Institutions within 30 days of commencing business in Wisconsin. The applicant will need to submit a Wisconsin Consumer Act (WCA) registration form and \$25.00 registration fee to the BCA if this application is approved. The WCA registration form is found on the Department of Financial Institutions' website, dfi.wi.gov, by selecting Consumer Services and then Wisconsin Consumer Act Forms

The provisions of the consumer loan agreement used by your company must comply with the WCA (Chapters 421 through 427) and Section 138.09 of the Wisconsin Statutes. Although you are not required to submit your consumer loan agreement in connection with your loan company application, you may forward your original consumer credit forms plus three copies of each consumer credit form to the BCA, the BCA will review the consumer credit forms for compliance with the WCA. Once the initial WCA registration has been filed with the \$25.00 fee, the service of reviewing your forms is free.
